The consumer has the right to withdraw from the distance agreement, or from goods purchased via the website www.cu-blue-lamps.rs, by signing a statement of withdrawal from the distance agreement.

The statement of withdrawal in the case of the distance agreement will be timely if it is sent to the seller by courier service to the address EUCOM Ltd. production, trade and services company, Milutin Milankovic 25v, 11070 New Belgrade, Serbia within 14 days from the date of receipt of the goods.

By unilaterally terminating the agreement, the consumer is released from contractual obligations, except for the direct costs of returning the goods.

The price of the goods will be returned to the consumer after the goods are returned to the seller from where the goods were sent to the consumer within 15 days from the day of receipt of the goods. In the case that the product returned to the seller is damaged or used, the consumer is solely responsible and the seller will refuse to return the money, and the product will be returned to the consumer at his expense. The consumer is solely responsible for the decreased value of the goods resulting from the use of the goods or the handling of the goods in a way that is not adequate, ie exceeds what is necessary to establish the nature, characteristics and functionality of the goods.

The costs of returning the goods and money are borne exclusively by the consumer, except in cases when the consumer receives the wrong product from the seller.
